



BILL EXPLANATIONS

Here are explanations for some of the most commonly asked about portions of the RPU bill.

ACCOUNT INFO

1 Billing date and customer account number

WATER CHARGE

Monthly charge for your use of water, measured in cubic feet (CCF).

2 Customer Charge

Fixed charge assigned to each metered service, based upon service rate, used to cover costs directly related to providing monthly electric and water services.

ELECTRIC CHARGE

Monthly charge for your use of electricity, measured in kilowatt hours (kWh).

3 Network Access Charge

Charge based on average daily electric usage designed to recover part of the costs for maintaining RPU's electric distribution system (poles and wires).

4 Reliability Charge

Flat charge assigned to each electric meter that is either based on the customer's amp panel size (residential) or according to the customer's service rate. This charge supports four peaking power units and an interconnection to the state power grid.

5 State Energy Tax

State-mandated charge of \$0.0003 per kWh; funds the work of the California Energy Commission.

CITY SERVICES

6 Utility User Tax

City tax applied to water and electric charges. This helps pay for things like street lights, park services and City programs.

7 Public Benefits Charge

State-mandated monthly surcharge of 2.85% of the total electric charge. Funds collected are used for low-income customer assistance, energy efficiency and conservation programs, renewable resources and energy research and development.

8 Sewer and Trash

Charges for sewer services, along with the collection of trash, green waste, and recyclables.

9 Sewer Public Benefits Charge

This fee assists the Public Works Department in creating and supporting programs that encourage customers to implement technology and best practices that reduce their discharge into the sewer system.

10 Water Conservation Surcharge

Monthly surcharge of 1.5% of the total water charge. Funds collected are used to support water conservation and efficiency programs.
